## BC Resolution # 01-08-97-G

*Regarding Amending the Community Support Policy*

WHEREAS, the Oneida General Tribal Council is the duly recognized governing body of the Oneida Tribe of Indians of the Wisconsin, and

WHEREAS, the General Tribal Council has been delegated the authority of the Constitution of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee may be delegated duties and responsibilities by the Oneida General Tribal Council and is at all times subject to the review powers of the Oneida General Tribal Council, and

WHEREAS, the Community Support Policy was adopted by resolution BC-5-15-96-A in accordance with the Administrative Procedures Act, and

WHEREAS, there have been required Public Hearings for the original policy, and

WHEREAS, the Community Support Fund and the Program have continuously been under the direction of the Governmental Services Division and located within the Income Maintenance Program which is a subset of the Social Services Program, and

WHEREAS, relocating the Community Support Fund and the Program to the subset of the Governmental Services Division Social Services Program does not amend the Community Support Program in any manner and is merely a reorganization plan,


NOW THEREFORE BE IT RESOLVED, that the Community Support Policy is hereby amended:

Sec. 1-1. The Purpose of this policy is for the Oneida Tribe to continue providing services to its membership by implementing the Community Support Services Fund under the *Social Services Program* of the Oneida Tribe of Indians of Wisconsin.

Sec. 2-1. This policy is adopted by the Oneida Business Committee by resolution # BC-5-15-96-A, and amended by resolution # BC-01-08-97-G, that delegates responsibility and authority to the Community Support Services Program under the administration of the *Social Services Program of the Oneida Tribe of Indians of Wisconsin*.
