## RESOLUTION # 04-08-98-L 2046-48 Packerland Drive, Green Bay, WI.

**WHEREAS**, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and Treaty Tribe recognized by the laws of the United States, and;

**WHEREAS**, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and;

**WHEREAS**, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and;

**WHEREAS**, the Oneida Housing Authority is a Corporation intended to supply adequate and suitable housing for the Oneida area;

### Land Description:

**PARCEL 1:** Lot One (1), according to the recorded Plat of Vista Grande, said Plat being part of Government Lot Twenty-Two (22) of Section Thirty-Two (32), Township Twenty (20) East, in the Fourth Principle Meridian, in the City of Green Bay, West Side of the Fox River, Brown County, Wisconsin.

**PARCEL 2:** Part of the South half of the Northeast Quarter of the Southwest Quarter (S $\frac{1}{2}$  of NE $\frac{1}{4}$  of SW $\frac{1}{4}$ ) of Section Thirty-Two (32), Township Twenty-Four (24) North, Range Twenty (20) East, in the Fourth Principle Meridian, in the City of Green Bay, West Side of the Fox River, Brown County, Wisconsin, described as follows:


Beginning at the southeast corner of Lot One (1), according to the Plat of Vista Grande, thence S 0° (Degrees), 29 min. 00 sec. E, 5.00 feet along the westerly right-of-way of Packerland Drive, also known as County Trunk Highway "EB", thence S89° (Degrees) 42 min. 29 sec. W, 178.96 feet; thence N 0° (Degrees) 24 min. 00 sec. W, 5.00 feet, to the southwest corner of said Lot 1; thence N89° (Degrees) 42 min. 29 sec. E, 178.95 feet along the southerly line of said lot to the point of beginning.

for the purpose of the WIS 10-14 (LOW RENT), which was approved by the Department of Housing Urban Development for 20 low rent housing units;

**THEREFORE BE IT RESOLVED** that the Oneida Housing Authority understands that this land is to be used strictly for the purpose of purchasing 1 low rent housing unit, and if this is not used for that purpose, it will be transferred back to the Oneida Tribe of Indians of WI.
