Oneidas bringing several hundred bags of corn to Washington's starving army at Valley Forge, after the colonists had consistently refused to aid them.


RESOLUTION #6-16-99-T REGARDING PARDON OF DIANE M. WILSON

- WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States, and the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV., Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council and
- WHEREAS, The Oneida Screening Committee has presented a Pardon Petition on behalf of DIANE M. WILSON and,
- WHEREAS, the requirements of the Oneida Pardon Ordinance and Oneida Pardon Procedures Policy have been fulfilled, and
- WHEREAS, the Oneida Screen Committee hereby recommends X GRANTING-DENYING the Pardon Petition of DIANE M. WILSON PETITIONER

NOW THEREFORE BE IT RESOLVED: That the Oneida Business Committee by this resolution hereby:
X GRANTS the Pardon of DIANE M. WILSON petitioner and notifies the Oneida Nation and its employing agencies that the Petitioner is recognized as a member of the Oneida Nation to have all the benefits and employment opportunities available to all other persons as if the criminal past pardoned by this Resolution did not exist. This pardon is granted by the signature of all members of the Oneida Business Committee members on the attached Pardon Certificate.
 DENIES the Pardon of Petitioner and notifies the Petitioner that he/she may request another pardon after one year from the date of certification of this document.

Certification

I, the undersigned, as Secretary of the Oneida Business Committee, hereby certifies that the Oneida Business Committee is composed of 9 members of whom 5 members constitute a quorum. 7 members were present as a meeting duly called, noticed and held on the 16th day of June, 1999; that the foregoing resolution was duly adopted as such meeting by a vote of 6 members for; 0 members against; and 0 members not voting; and that said resolution has not been rescinded or amended in any way.
