RESOLUTION # 8-23-95-Q

- WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and a Treaty Tribe recognized by the laws of the United States, and
- WHEREAS the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1. of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS, the Oneida Tribe has acquired in fee status the following parcel described as: Timothy J. Besaw - Westpoint.
Tax Parcel No.: 6H-1268-1-1
- WHEREAS, the parcel is described as follows:
That part of Government Lot)ne (1), in Section Thirty-three (33), Township Twenty-four (24) North, Range Twenty (20) East, in the city of Green Bay, West Side of Fox River, Brown County, Wisconsin, described as follows:
Commencing at the Northwesternly corner of Lot 2, thence Easterly 710.40 feet to the point of beginning; thence Southerly 279 feet; thence Easterly 76 feet; thence Northerly 279 feet; thence Westerly 76 feet to the place of beginning, except those parts thereof described in Volume 944 of Records on Page 346 and in Jacket 3272 Records, Image 35, Brown County Records. Parcel contains .70 acres more or less.
- WHEREAS, the above described parcel is requested in trust status to expand Oneida Tribal land base and provide a future site for economic development, housing, recreation, conservancy, and agriculture, and
- WHEREAS, the Oneida Business Committee certifies that the local property taxes will be paid up to trust placement, and


