WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, The Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, Leona Smith is holder of lease no. B-498(68), described as follows:

A parcel of land in the NE1/4 SE1/4 Section 11, T 23N., R 18 E., 4th P.M., Wisconsin, more particularly described as follows: Commencing at the East quarter corner of Section 11, T 23 N., R 18 E., thence West on the quarter section line 396 feet to the point of beginning, thence West on the quarter section line 264 feet; thence South 330 feet; thence East 264 feet; thence North 330 feet to the point of beginning, containing 2.0 acres, more or less, subject to valid rights-of-way of record.


WHEREAS, Leona Smith, holder of lease no. B-498(68) no longer intends to use said lease site.

NOW, THEREFORE BE IT RESOLVED, that the Oneida Business Committee in REGULAR Session assembled, hereby approves the \*CANCELLATION of lease no. B-498(68),
