RESOLUTION # 10-29-97-1 Tammy Kurowski Residential Lease

WHEREAS, the Oneida Tribe of Indians of Wisconsin is a Federally recognized Indian government and a Treaty Tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section of the Oneida tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, Tammy M. Kurowski, #8854, a/are Tribal Member(s), have made application for a long-term lease for residential purposes; and

WHEREAS, Tammy M. Kurowski, #8854, has/have been designated Lease No. RL-2820(97) for the Tribal land selected and is more particularly described as follows: 904 Riverdale Drive, Oneida, WI 54155.

Parcel A: Part of Indian Claim 202, Town of Hobart, Brown County, Wisconsin, more fully described as follows: Commencing at the northeast corner of Indian Claim 200; thence NO degrees 10'06"W, 297.72 feet along the east line of Jacket 2866, Image 13, to the Southwest corner of Jacket 6203, Image 40, both Brown County Records; thence N89degrees 49'54"E, 586.47 feet along the south line of said Jacket 6203, image 40, to the point of beginning: Thence continuing N89degrees 49'54"E, 646.00 feet along said south line to the westerly right-of-way of C. T. H. "J" also known as Riverdale Drive; thence 195.14 feet along said westerly right-of-way being the arc of a 1105.95 foot radius curve to the right whose long chord bears S39degrees 30'20"W. 194.88 feet; thence S89degrees 49'54"W, 521.58 feet; thence NO degrees 10'06"W, 150.00 feet to the point of beginning. Parcel contains 88.128 square feet/2.02 acres, more or less.

WHEREAS, the Oneida Tribe of Indians of Wisconsin's Division of Land Management is responsible for managing all tribal real property assets, including leases, through rules and policies approved in Oneida Real Property Law; and


NOW, THEREFORE, BE IT RESOLVED by this Committee in Regular assembled, hereby requests the Superintendent, Great Lakes Agency, to draft a lease in accordance with the Act of August 9, 1955 (69 Stat, 539), as amended, 25 USC 415, for the above-described land with a 25 year term which shall automatically and without notice renew for an additional term of 25 years at a total rental, \$1.00 per year or \$50 for fifty years, at a total rental to be determined by an appraisal. and

BE IT FURTHER RESOLVED that the Chairman and Secretary of the Oneida Business Committee are hereby authorized to execute lease documents for and on behalf of the Oneida Tribe.

BE IT FURTHER RESOLVED that Christine M. Doxtator, Land Management Director, or her designee, be authorized to execute said lease agreement on behalf of the Oneida Tribe.
