Diana Metoxen Residential Lease

WHEREAS, the Oneida Tribe of Indians of Wisconsin is a Federally recognized Indian government and a Treaty Tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, Diana K. Metoxen, #4746, a/are Tribal Member(s), have made application for a long-term lease for residential purposes; and

WHEREAS, Diana K. Metoxen, #4746, has/have been designated Lease No. RL-2793(96) for the Tribal land selected and is more particularly described as follows: W355 Old Seymour Road, Oneida WI 54155.

Parcel B

Part of Claim 134 being located in Southwest ¼-Northwest ¼, Section 4, T23N-R19E, Town of Oneida, Outagamie County, Wisconsin, Fourth Principle Meridian more fully described as follows:

Commencing at the SW corner of Indian Claim 134, thence N89° 56'06" E, 424.23 feet along the south line of the Northwest ¼, Section 4, T 23 N., R 19 E., also being the south line of said Indian Claim 134, to the point of beginning; thence N14°41'28"E, 138.09 feet; thence S75°36'03"E, 267.72 feet along the southerly right-of-way of Old Seymour Road; thence S65°19'52"E, 159.33 feet along said right-of-way; thence S89°56'06"W, 439.12 feet along the said south line of the Northwest ¼ and Indian Claim 134, to the point of beginning. Parcel contains 33,120 square feet /0.76 acres, more or less.

WHEREAS, the Oneida Tribe of Indians of Wisconsin's Division of Land Management is responsible for managing all tribal real property assets, including leases, through rules and policies approved in Oneida Real Property Law; and


NOW, THEREFORE, BE IT RESOLVED by this Committee in Regular assembled, hereby requests the Superintendent, Great Lakes Agency, to draft a lease in accordance with the Act of August 9, 1955 (69 Stat, 539), as amended, 25 USC 415, for the above-described land with a 25 year term which shall automatically and without notice renew for an additional term of 25 years at a total rental, \$1.00 per year or \$50 for fifty years, at a total rental to be determined by an appraisal, and

BE IT FURTHER RESOLVED that the Chairman and Secretary of the Oneida Business Committee are hereby authorized to execute lease documents for and on behalf of the Oneida Tribe.

BE IT FURTHER RESOLVED that Christine M. Doxtator, Land Management Director, or her designee, be authorized to execute said lease agreement on behalf of the Oneida Tribe.
