RESOLUTION # 11-29-95-14

WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and Treaty Tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, Todd Metoxen, tribal member, Lease Number RL-2142(90) more particularly described as follows:

A parcel of land located within SE $\frac{1}{4}$ NW $\frac{1}{4}$ Section 24, T. 23N., R. 18E., more particularly described as follows: Commencing at the SE Corner of the NW $\frac{1}{4}$ Section 24, which is the Point of Beginning; thence S.87°43'13"W., a distance of 132.06 feet; thence N.00°29'47"W., a distance of 662.56 feet; thence N.87°45'28"E., a distance of 132.06 feet; thence S.00°29'47"E., a distance of 662.47 feet, more or less, to the Point of Beginning, containing 2.00 acres, more or less, subject to all valid existing rights-of-way of record.

WHEREAS, Lessee(s), members of said lease site with to modify lease number RL-2142(90) as follows:

Delete: Todd Metoxen, a tribal member.

Insert: Todd and Tina Metoxen, tribal members.

NOW, THEREFORE, BE IT RESOLVED by this Committee in Regular session assembled, hereby approved the modification of this lease

BE IT FURTHER RESOLVED that the Chairman and Secretary of the Oneida Business Committee are hereby authorized to execute lease modification documents for and on behalf of the Oneida Tribe.
