BC Resolution # 6-04-03-A

Resolution Adopting Amendments to the Hunting, Fishing and Trapping Law

WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS, the Oneida Business Committee adopted the Hunting, Fishing and Trapping Law in April, 1996, and has amended the Law in July of 1998, and September of 2000, and

WHEREAS, the Environmental Resource Board and Conservation Department have forwarded recommended changes to the law which, among other things, increases license and permit fees and sanctions for the first time in over two years, and provides a detailed section for "Other Affiliation Sportsman Licenses," and

WHEREAS, uniform regulation helps to monitor and maintain fish and game within the reservation under Tribal jurisdiction, and

WHEREAS, the amendments to the Hunting, Fishing and Trapping Law have been presented at Public Hearings held on October 8, 2002 and March 25, 2003 and the comments and testimony have been reviewed and integrated as appropriate.

NOW THEREFORE BE IT RESOLVED, that the Oneida Business Committee hereby adopts the attached amendments to the Oneida Hunting, Fishing, and Trapping Law, and

NOW THEREFORE BE IT FURTHER RESOLVED, that the amendments shall be effective for new permits and licenses issued after adoption of these amendments, and


NOW THEREFORE BE IT FURTHER RESOLVED, that current permits and licenses shall be applicable and expire as set forth in the law prior to the adoption of the amendments, if renewable, shall be renewed under the law as amended, and

NOW THEREFORE BE IT FURTHER RESOLVED, that the Environmental Resources Board is directed to develop and schedule any necessary public meetings to disseminate the changes in this law to the public, and

NOW THEREFORE BE IT FINALLY RESOLVED, that the Conservation Department is directed to identify individuals holding licenses and mail a postcard indicating that changes to the Hunting, Fishing and Trapping Law have been adopted, effective date, and when copies of the amended law will be available.
