BC Resolution # 03-09-16-B Regarding Pardon of Judith Saldana


- WHEREAS,** the Oneida Nation is a federally recognized Indian Government and a treaty tribe recognized by the laws of the United States; and
- WHEREAS,** the Oneida General Tribal Council is the governing body of the Oneida Nation; and
- WHEREAS,** the Oneida Business Committee is delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council; and
- WHEREAS,** the Oneida Pardon and Forgiveness Screening Committee reviewed the pardon application of Judith Saldana at a duly called hearing held on February 18, 2016; and
- WHEREAS,** the requirements of the Pardon and Forgiveness Law have been fulfilled, and

NOW THEREFORE BE IT RESOLVED, that the Oneida Business Committee by this resolution hereby:

The pardon has been denied based on the following:
1. Ineligible due to conviction in 2015.
 2. Unpaid fines.
 3. Come back in a year after everything is completed.
