
## Oneida Tribe of Indians of Wisconsin

## BC Resolution 03-14-12-C

## Creation of Business Entity Oneida ESC Group and Authorizing Filing or Organizational Documents in Appropriate Forum

WHEREAS,	the Oneida General Tribal Council is the duly recognized governing body of the Oneida Tribe of Indians of Wisconsin, and
WHEREAS,	the General Tribal Council has been delegated the authority of Article IV, Section I of the Oneida Tribal Constitution, and
WHEREAS,	the Oneida Business Committee may be delegated duties and responsibilities by the Oneida General Tribal Council and is at all times subject to the review powers of the Oneida General Tribal Council, and
WHEREAS,	the Oneida Business Committee authorized the creation of OTIE, Oneida Total Integrated Enterprises, to take advantage of federal contracting processes identified commonly as Section 8(a) businesses, and
WHEREAS,	OTIE has successfully applied for the Section 8(a) designation and is engaging in both competitive and Section 8(a) contracting opportunities, and
WHEREAS,	OTIE Board has identified that it is an appropriate time to begin creation of other companies which can participate in Section 8(a) contracting opportunities in different areas or NAICS codes, specifically in engineering, science and constriction fields, and

WHEREAS, the Oneida Business Committee has reviewed the business opportunity and recommendation to creation Oneida ESC Group, LLC for the purposes of operating the NAICS code Section 8(a) arena regarding engineering, science and construction and agrees with

that recommendation, and

WHEREAS,
OTIE Board has identified a source of funding that can be utilized to capitalize the start-up company Oneida ESC Group, LLC and has committed to assisting the company to begin operations in such a manner that does not jeopardize the operations of OTIE.

**NOW THEREFORE BE IT RESOLVED,** the Oneida Business Committee does hereby authorize the filing of Articles of Organization to create Oneida ESC Group, LLC as a Nevada limited liability company.

IT IS FURTHER RESOLVED, that he Oneida Business Committee does hereby approve the Operating Agreement for Oneida ESC Group, LLC and the disbursement of \$200,000 from OTIE as a distribution payment to the Member to be deposited directly to Oneida ESC Group, LLC as start up funding.

IT IS FINALLY RESOLVED, that the initial board of directors shall be Wilbert Rentmeester, Jackie Zalim and Jeff House who shall serve five year terms, all terms thereafter to conform to the terms of office set forth in the Operating Agreement.
