- WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS, the Oneida Tribe has determined as part of its Seven Generation Commitment "To develop a provision system that fits our "family"/community values such as food, shelter, clothing and child care as well as other services," and
- WHEREAS, the Oneida Tribe has established the Oneida Social Services/Center for Self Sufficiency Child Care Program and with a collaborative effort of the Oneida Education and Training Area/Child Care Programs to promote quality educational and employment support opportunities for all members of the Tribe from early childhood throughout life, in accordance with Oneida's need for cultural survival and well-being, and
- WHEREAS, the Oneida Center for Self-Sufficiency and Oneida Education and Training Child Care Programs with the collaboration of the State of Wisconsin/Division of Economic Support/Office of Child Care would like to improve the quality and quantity of child care services that are available in our community, and

**NOW, THEREFORE, BE IT RESOLVED:** That the Oneida Tribe of Indians of Wisconsin in collaboration with the State of Wisconsin/Division of Economic Support, authorizes and submits this grant application for the purpose of securing external monies to expand and improve the quality and quantity of child care services.
