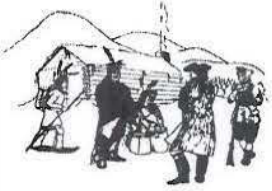


Oneida Tribe of Indians of Wisconsin

BC Resolution 05-09-12-A

Emergency Amendments to the General Tribal Council Meeting Stipend Payment Policy

- WHEREAS,** the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States of America, and
- WHEREAS,** the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS,** the Oneida Business Committee has been delegated the authority of Article IV of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS,** on November 21, 2011, the General Tribal Council approved Resolution GTC-11-21-11-A, which directed the Oneida Business Committee to amend the General Tribal Council Meeting Stipend Payment Policy (Policy) on an emergency basis no later than six months after the Resolution was passed, and
- WHEREAS,** the Resolution directed that the amendments limit individuals in a General Tribal Council meeting to members age 21 or over, until facilities can be identified that seat 2,500 or more people, and
- WHEREAS,** the Resolution also directed an additional amendment to the Policy to prohibit members who leave the ballroom area and related bathroom facilities from being eligible for a stipend payment, and
- WHEREAS,** the attached proposed amendments would satisfy those directives as contained in Resolution GTC-11-21-11-A, and
- WHEREAS,** the Administrative Procedures Act (APA) authorizes the Oneida Business Committee to enact legislation on an emergency basis, to be in effect for a period of six (6) months, renewable for an additional six (6) months, and
- WHEREAS,** the emergency adoption of amendments to the General Tribal Council Meeting Stipend Payment Policy is necessary for the preservation of the public health, safety, or general welfare of the reservation population, and that observance of the regular APA adoption requirements for passage of laws would be contrary to public interest.

NOW THEREFORE BE IT RESOLVED, the attached amendments to the General Tribal Council Meeting Stipend Payment Policy are hereby adopted on an emergency basis.

NOW THEREFORE BE IT FINALLY RESOLVED, in accordance with GTC-11-21-11-A, the Oneida Business Committee shall notify members that these changes have been implemented.

CERTIFICATION
