BC Resolution 09-26-14-A Regarding the Requirement of Three OBC Officer Signatures to Open the Youth Development Fund at Bay Bank GB

WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States of America, and

WHEREAS, the Oneida General Tribal Council is the duly recognized governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

whereas, the Oneida Business Committee approved the creation of the Youth Development Fund by adoption of resolution # BC-05-15-14-G which allows the creation of a bank account to accept charitable donations to be deposited and used in accordance with the fund, and

WHEREAS, the Youth Development Fund has received donations to be deposited in the account to be created at Bay Bank GB, and

WHEREAS, the Oneida Business Committee is required to submit a signature card with the signatures of four officers to open the account where no specific direction has been given otherwise, and

WHEREAS, it has not been possible to obtain the signatures of all four officers and opening the account can no longer be delayed, and

WHEREAS, the Oneida Business Committee desires to set the requirements for the signature cards for the Youth Development Fund,

NOW, THEREFORE BE IT RESOLVED, that the Oneida Business Committee authorizes the following three officers as the official(s) necessary on the signature card to open the Youth Development Fund account at Bay Bank GB –

- Melinda J. Danforth, Vice-Chairwoman
- Patricia King, Treasurer
- Lisa Summers, Secretary

THEREFORE BE IT FINALLY RESOLVED, that the Treasurer, or her designee, shall present the original of this resolution on file as notice of the authority to open the account.
