WHEREAS, The Oneida Nation of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Nation of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Nation Constitution by the Oneida Nation General Council, and

WHEREAS, Congress by enactment of the Transportation Equity Act of the 21 Century (TEA st 21) provided a mechanism for Indian Tribes to exercise the right to SELF-DETERMINATION, and

WHEREAS, the Transportation Equity Act for the 21st Century (TEA 21), has provided funding to the Bureau of Indian Affairs for the purpose of Transportation Planning on Oneida Nation Land, and

WHEREAS, the Oneida Nation granted a right-of-way to the Bureau of Indian Affairs for Water Circle Place located on the Oneida Nation Reservation and authorizes its Chairman and Secretary to negotiate for the planning and construction of the same, and

NOW THEREFORE BE IT RESOLVED: the Bureau of Indian Affairs, under Public Law 93-638, has offered to the Oneida Nation Contract No. CTF55T43351 for \$110,000.00 for the purpose of Water Circle Place planning and construction.
