
Oneida Tribe of Indians of Wisconsin

BC Resolution 10-13-10-C Resolution to Resume Employer Matching Contributions to the Tribal Retirement Plans

- WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States (the "Tribe"), and
- WHEREAS, the Oneida General Tribal Council is the duly recognized governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS, the Tribe sponsors the Oneida Tribe of Indians of Wisconsin Retirement Savings and 401(k) Plan (the "Tribal 401(k) Plan"), the Oneida Tribe of Indians of Wisconsin Business Committee 401(k) Plan (the "BC 401(k) Plan"), and the Oneida Tribe of Indians of Wisconsin Deferred Compensation Plan (the "DCP") and
- WHEREAS, the Tribal 401(k) Plan, the BC 401(k) Plan and the DCP (collectively, the "Retirement Plans") allow the Tribe, in its discretion, to make employer matching contributions on behalf of eligible participants, and
- **WHEREAS**, the Tribe currently makes no employer matching contributions to the Retirement Plans, and
- WHEREAS, in light of the fact the Oneida Business Committee wishes to recognize and reward the contributions of the employee base of the Oneida Tribe of Indians of Wisconsin by resuming the employer matching contributions to the Retirement Plans, and

NOW THEREFORE BE IT RESOLVED, that the employer matching contributions to the Tribal 401(k) Plan, the BC 401(k) Plan and the DCP shall be reinstated, effective as of the payroll period beginning 10/3/2010 and ending 10/9/2010, and, that the employer matching contribution amount for the Tribal 401 (k) Plan and the BC 401 (k) Plan and the participants in the Deferred Compensation Plan shall be on a dollar for dollar basis, equal to the first 2% of the compensation deferred by each eligible participant.

BE IT FURTHER RESOLVED, that for purposes of the DCP, this Resolution shall serve as a declaration of all Participating Employers, without requiring further action of any Participating Employer.

BE IT FINALLY RESOLVED that the actions taken by Tribal officers and personnel in connection with the matters addressed in these resolutions be, and hereby are, ratified, confirmed and adopted as actions of the Oneida Tribe of Indians of Wisconsin.

CERTIFICATION
