BC RESOLUTION <u># 11-03-04-A</u> Emergency Adoption of Amendments to ONGO

- WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States of America; and
- WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin; and
- WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV of the Oneida Tribal Constitution by the Oneida General Tribal Council; and
- WHEREAS, the Oneida Nation Gaming Ordinance (ONGO) was adopted by the General Tribal Council (GTC) on July 5, 2004; and
- WHEREAS, the Indian Gaming Regulatory Act (25 USCA § 2710) requires National Indian Gaming Commission (NIGC) approval of Tribal gaming ordinances; and
- WHEREAS, the ONGO was submitted for NIGC approval in July 2004; and
- WHEREAS, the NIGC has approved the Tribe's submission, but has requested that the Tribe make certain technical amendments to the ONGO as soon as possible; and
- WHEREAS, Article VI of the Administrative Procedure Act (APA) authorizes the Oneida Business Committee to enact legislation on an emergency basis, to be in effect for a period of six months, renewable for an additional six months; and
- WHEREAS, the Oneida Business Committee finds that it is necessary to comply with the NIGC recommendations as soon as possible, and this constitutes an emergency situation which requires the immediate passage of amendments to the ONGO; and
- WHEREAS, emergency adoption of the amendment is necessary for the preservation of the public health, safety, or general welfare of the reservation population, and that observance of the regular APA adoption requirements for passage of laws would be contrary to public interest.

NOW THEREFORE BE IT RESOLVED, that the Oneida Business Committee hereby adopts the following emergency amendment to the Oneida Nation Gaming Ordinance:

21.10-2. Application Procedure for License. Every person seeking employment with a Gaming Operation shall submit an application to the Commission on such form or in such manner as the Commission may require. At a minimum, the application shall contain the following information detailed below. The Gaming Commission shall amend the application procedure for a Gaming Employee License in the event that the Tribe receives notice that the procedure must be modified to conform to any NIGC standard.

(u) Each application shall be accompanied by a complete set of fingerprints of the applicant taken by Oneida Backgrounds Department personnel who have been trained by a law enforcement agency or taken by the Oneida Police Department.

21.10-3. *Qualifications*. The Tribe shall conduct a criminal history check on all applicants. The criminal history check shall include a check of criminal history records information maintained by the Federal Bureau of Investigation, as well as state and local governments. The Tribe shall interview a sufficient number of knowledgeable people, such as former employers and personal references, in order to provide a basis for the Tribe to make a finding concerning eligibility, and the Tribe shall document potential problem areas and disqualifying information regarding applicants.

21.10-4. *NIGC Review*. When an individual begins applies for employment at a Gaming Operation, the Commission shall:

(h) In the event that the applicant is determined to be ineligible for a Gaming Employee License, the Commission shall forward the name of the applicant to the NIGC.

21.13-4. *Player Disputes*. The Tribe shall provide and publish procedures for fair and impartial resolution of patron complaints.
