JANUARY 10, 1982

Meeting called to order at 10:30 A.M. by Chairman.

Discussion on GTC action of Janaury 8, 1983

Action was taken by the General Tribal Council to put the Oneida Tribal school board in complete charge of the education programs for the Tribal school and the Oneida Tribal School board. Business Committee members are directed to enter into a memorandum of agreement relative to the administration of the school. The action taken was not fully understood by some members of the Business Committee. Tony Utschig has a meeting with the Oneida Tribal school board on January 11, 1982 and he will ask the Board what points they feel they should be in charge of at the school and a meeting would be set for the following week between the School Board and the Business Committee to begin discussion on the memorandum of agreement.

Indian Study Commission Meeting

A meeting is scheduled in Madison on January 11, 1983 for the Indian Study Commission. Loretta requested to attend this meeting. Gordon made a motion to approve Loretta's request to attend the ISC meeting in Madison. Lloyd seconded. Loretta abstained. Motion carried.

NCAI Convention in Green Bay

Up to the present time Stan Webster is the person working on the NCAI Convention and the Business Committee feels it is necessary to have members of the

Business Committee involved. Gordon made a motion to have Loretta, Norbert and Lloyd work as a sub-committee to be in charge of working on the NCAI Convention. This sub-committee would contact Stan Webster to work out an arrangement on his participation with the convention. Lois seconded. Motion carried.

NCAI Delegate from the Oneida Tribe

Norbert made a motion to adopt the NCAI delegate resolution #1-10-83-A. Loretta seconded. Motion carried.

RESOLUTION # 1-10-83-A

- WHEREAS, the Oneida Tribe of Indians of Wisconsin have been associated with the National Congress of American Indians for a number of years, and
- WHEREAS, our Tribal Chairman, Purcell Powless, or Vice-Chairman, Norbert Hill has been authorized to represent the Oneida Tribe of Indians of Wisconsin as our official Tribal voting delegate, and this resolution would rescind any former action,
- NOW THEREFORE BE IT RESOLVED, that the National Congress of American Indians staff is hereby directed to accept the delegate of the Oneida Tribe of Indians of wisconsin and to distribute said resolution to the appropriate offices as well as to the National Congress of American Indians membership.

Job Training Partnership Act

The Business Committee met with Raymundo Chavera, the Migrant and Native American Coordinator. The topic of discussion centered around his agency and his position as Coordinator. This is a newly developed position created to establish better communication between our office and the Native American programs and other agencies providing services to Native Americans and Migrants in the state of Wisconsin.

JTPA is replacing CETA effective October 1, 1983. It is the responsibility of the state to provide training on the laws and regulations during the transition period. Ray Chavera's office hopes to accomplish the following goals:

- Establishing a needs/assessment process as a instrument for identifying agency needs and success.
- (2) Identify and develop a Management Assistance program for agency staff, (coordinated with our training program - training director and Native American Agency heads)
- (3) Prepare recommendation on how state agencies can be better utilized by Native American Programs.
