# DICK SHIKOSKI

Question on the Pension Plan. No action taken. Question on the WIPFLI

An up-date on the Enterprise & Discretionary Fund from Dick.

One Audit concept Up-Date: Dick feels the one-audit concept is a good route to go. He has talked to people at OIG, the WIPFLL Consultants and they also see the One-Audit Concept as a good thing for the Tribe. Dick feels it will be very helpful in the Accounting Department. The Audit can be paid through Indirect Cost and that is what Dick would recommend. The Business Committee approved that Dick should look into the One-Audit Concept and see it it would benefit the Tribe. The next step would be to approve some kine of an agreement to have the One-Audit done. This could be done with the auditors the Tribe has been working with and get some other bids. This would be for fiscal year 9/30/82.

Mark suggested the Business Committee review the Housing Ordinance of the Housing Authority and see if we can also work them into the One Audit Concept.

Questions on Indirect Cost: The Tribe has not received the Indirect Cost Rate at this time. Dick stated he had answered all the question that were brought up and that in a short time the Tribe should have an answer. Mark felt maybe we should send one of the Tribal officers to Denver to get this answer because they have been promising for sometime that we would get the indirect cost and also because by the time they send this it maybe to late and we may not get a cost. Norbert felt we should also go through our Congressional delegates and have them inquire on our behalf to help shake this loose. Dick will call Denver today and try to find out why we have not received an answer and if we have to we'll send someone to Denver.

Dick said if someone goes to Denver they should look into the ITAC Program and why we have not received \$40,000 since 1980. With the BIA Audit this should have been cleared up but the money has not been forthcoming. Oneida Tribe of Indians of Wisconsin Special Meeting - March 15, 1982 Page 2

# ECONOMIC IMPACT ON THE SOLAR BUILDING

Bruce has negotiated a lease with the Energy Marketing Group for a 3,000 sq. ft. building on Lot No. 5 of the Industrial Park. The lease would be for five years at a rate of \$4.05 per sq. ft. per year with monthly payments of \$1,013 per month. The five-year lease would bring \$60,780 back to the Tribe. At the end of the five year period, the lease would be adjusted to the fair-market value.

<u>Oneida One-Stop</u>: Bruce gave an update on the operation of One-Stop. Quotes are coming in on the improvement and the erection of the sign. The quotes are running somewhat higher than the estimates so in some areas they will be a little short but Carl has been able to come up with savings in other areas, so this will balance out. One-Stop has also been pumping more gas than estimated at this time. Things are moving on schedule. Bruce will bring a written report on the operation to the Business Committee.

Arts & Crafts: A budget will be given to the Business Committee on Wednesday, March 17, 1982 and a meeting will be held on March 18 to discuss the proposal.

## JOE VILLEGOMEZ - PERSONNEL MANAGER

Joe asked what the Business Committee is going to do with the job posting of General Manager. Also Personnel Selection Committee, the Organizational Chart three committees; Health, Bingo, Nursing.

The Land Office funding is running out for personnel and the Business Committee has to decide where they intend to draw this money from. Vera Wilson was laid off in January, 1982. Joe said Revenue Sharing could be used for funding for the Land Office.

#### HEALTH CENTER

From January and February there has been an increase in Third Party Billing amounts. The amount is 2/3 greater this year compared to the same last year.

## BINGO TRAVEL REQUEST

The Bingo Committee made a request to go to Florida May 25-27. In the discussion the Business Committee felt maybe this should be put off until a later time when we have more of the answers about the new construction.

### HEALTH BOARD

better to have a workshop of that nature put on here in Oneida and then we could get more people to attend.

Joe requested to go to a one-day workship in Green Bay dealing with hiring and firing. The Business Committee agreed and also suggested the new Tribal Administrator to attend the workshop on April 9, 1982.

Mark asked about the ITAC Contract. Joe said he had a meeting set up with Ted White. Ted was hired to close out this contract. Joe is to call Mark when this meeting will take place.

#### LAW OFFICE

Jerry Hill discussed his memo to the Business Committee of March 10, 1982 in regard to the first meeting of the American Indian Study Committee of the Wisconsin Legislative Council.

This Committee first met on March 5, 1982 in the State Capitol in Madison, Wisconsin. It is the successor to an earlier Committee, the Native American Study Committee aughorized under Section 13.83, Wis. Stats., which also prescribes the functions of the Committee. The Committee fell into disuse several years ago, when Indian members and legislators failed to establish the commitment necessary to success. The revival of this Committee is a new attempt to commence a dialogue between the Tribes and the State of Wisconsin regarding State Legislation affecting Indian Tribes.
