# BUSINESS COMMITTEE ACTION ON THE ARCHIVES - Tony Benson Memo of 5/27/82

Tony Benson stated in his memo, "I am in full agreement that the Oneida Tribe should have an archives. I was also pleased when a proposal to set up an archives was submitted.

However, the Business Committee has discussed on many occasions the procedure we should use in accepting proposals. We have also set precedents in handling proposals that we have not had time to review and evaluate.

I will cite minutes of 1-7-82 when the Committee refused to take action because there was not enough time for proper evaluation. Also, minutes of 2-2-82 when there were four reasons specified for not accepting aproposal: (1) Little time if any, to consider long range plans beyond the two year grant. (2) May be duplicating services we already have. (3) Cannot identify \$8,718 at this time. (4) Eleventh hour presentation does not provide enough time for study to make an intelligent decision. This motion was passed unanimously.

Further, our integrity is questionable when a member of the Committee votes on a proposal submitted by his spouse.

I am asking for two considerations: (1) that the Business Committee reconsider its actions on 4-27-82 of approving the proposal of Thelma McLester. (2) that this memorandum be placed in the Tribe's permanent files for future reference."

Wendell stated he voted on the acceptance of the proposal and who ever submitted the proposal had nothing to do with the vote. He also stated the Business Committee was not voting to select a person to run the archives. After further discussion, Tony made a motion that the Business Committee reconsider the action taken on the acceptance of the archive proposal and bring it back for discussion. Joy seconded. Mark said he hopes the Finance Committee considers the amount of money now being spent for the museum and if we can afford the additional expense.

Wendell said the proposal shows the archives would be housed in a building that is already being used by the Tribe.

Vote was 4 yes, Frank opposed, Wendell & Gordon abstained. The Chairman said some action should be taken within the next 10 days.

# BUSINESS COMMITTEE REQUESTS

Joy Ninham asked for a vacation on June 7 and 8, 1982. Tony moved to approve rank seconded. Joy abstained. Motion carried.

Frank Cornelius said he has a sick day doctor appointment on June 21, 1982. Mark moved to approve. Wendell seconded. Frank abstained. Motion carried.

Norbert Hill said he has a sick day doctor appointment on June 11, 1982. Wendell has to go to the Minneapolis area to work on the Indirect Cost with the BIA on June 7, 1982.

Mark asked who will handle the travel of the Business Committee? Pat Benson will handle the travel.

Joy gave an update on the Recreation Program. Cliff Danforth failed to follow up on his grievance on Friday. Norbert moved to recess at 12:00. Frank seconded. Motion carried.
