#### DIANE FUNMAKER GARNISHMENT

Diane is requesting the 20% garnishment be lowered to 10% due to her financial hardship. Mark made a motion to reconsider lowering her garnishment from 20% to 10%. Lloyd seconded. 2 voted yes (Mark & Lloyd), 3 voted no (Tony Kathy Gordon), 1 abstained (Lois). Motion fails. Kathy made a motion to table until Wednesday, July 20, 1983. Lois seconded. Mark opposed. Motion carried.

### LETTER ON TRIBES POSITION REGARDING BINGO

The following letter will be sent to Mr. Ken Smith, Assistant for Indian Affairs in Washington, D.C. contingent on Business Committee approval:

#### Dear Mr Smith:

This letter is in regard to the BIA Task Force meeting on Bingo held in Washington, D.C. on June 10-11, 1983 concerning Tribal Bingo's. The Oneida Tribe is very upset that the requests which the Tribes made had been denied by the Bureau of Indian Affairs. The Tribes present at the meeting requested the following:

- That a meeting be called the week of July 18, 1983 in Oklahoma City and that all Tribes concerned be contacted.
- 2) That the Justice Department officials, James Watt, Ken Smith, and John Fritz be present at the meeting of July 18, 1983.
- 3) It was stated by Hazel Elbert that some Congressmen had put pressure on the Justice Department to draft legislation regarding Indian Bingo's. We had requested specifically who their Congressmen were, where they came from and their concerns.
- 4) It was also requested that a copy of that portion of Bill H.R. 2151 on Bingo that was deleted be available.

The Tribes have no official response to any of these questions as of this The Tribes were also upset over the fact that no decision makers from any of the agencies were in attendance at the meeting. The Tribal Chairman were called to Washington and Denver to met with the BIA who sent administrative aides to meet with heads of Tribal Governments. Where was Ken Smith, John Fritz and Justice officials? We view this situation as an extreme emergency. supposedly works for the Tribes. With that in mind, we call for a meeting with all Tribes concerned to meet and develop our own positions. We further request that National Congress of American Indians and National Tribal Chairman Association call for such a meeting to have the Tribes unite under one position and forward that position on the the Bureau of Indian Affairs in response to Justice Departments concern over Indian Bingo. We also request that the National Congress of American Indians and the National Tribal Chairmans Association contact you, John Fritz and James Watt and the Justice Department to have their officials in attendance at this proposed meeting. We need to act as quickly as possible. Rumor has it that the Bureau of Indian Affairs and the Justice Department amde a trade off: The BIA would have regulations drafted by September 30, 1983 for which in turn that portion of H. R. 2151 regarding Indian Bingo's was deleted from that Bill. We ask for your support and cooperation.

## STATE BANK OF DEPERE TO PURCHASE FROM TIME TO TIME WHEN SIJCK BECOMES AVAILABLE

Kathy would like to have approval ahead of time to purchase holdings that would become available at any time. Kathy recommended that we not exceed \$68.00 per share and not to exceed 300 shares. These was a question as to earlier action taken giving approval to purchase stock. Mark made a motion to table until more research is done on any earlier action. Tony seconded. Motion carried.

## RESOLUTION #7-18-83-A CONCERNING A FULL-TIME INDIAN COORDINATOR IN THE BEMIDJI AREA OFFICE - Marj Stevens, Health Center

Mark made a motion to adopt Resolution #7-18-83-A which states, "that the Bemidji Area Office take immediate action to ensure that the Alcoholism programs will have a full-time Indian Coordinator, knowledgeable about alcoholism, due to the sensitive area of Indian alcoholism. That immediate action will be taken to increase funding levels for the Bemidji service area and other service areas of the nation as well", and that this Resolution also be sent out to other tribes in Wisconsin requesting support. Lloyd seconded. Motion carried.

## CHD QUARTERLY REPORT - Jerry Hill

Kathy made a motion to approve the CHD quarterly report. Lloyd seconded. Motion carried.

## MARY LEMIEUX'S EMPLOYMENT - Jerry Hill

Jerry sent the Business Committee a memo regarding Mary's employment, as follows:

"This is to follow up an earlier memo in which I raised the matter of recalling the above named person to the Law Office when I return to employee status. As you know the contract under which I am now retained expires on September 30, 1983. In order to avoid any delay in the implementation of the law department, it is requested that Mary be recalled as a full-time employee as of September 1, 1983.

I further request that Mary be granted a raise to reflect the annual cost of living and merit raises. This should also be compatible with the salary of the Clerk of the Tribal Court. I request that we meet to discuss this at your earliest convenience so that we may avoid any confusion on this matter."
