220-HUNTING & FISHING ORDINANCE/LAW OFFICE

Discussion on present problems the DNR and County Law Enforcement Officers have with hunting and fishing. Most, if not all the agencies realize the Treaty Rights of Indians in the State. The biggest problem is identification of Tribal members. Jerry Hill presented a draft ordinance and resolution which listed three options. (Kathy excused at 9:45). After reviewing the three options, the Business Committee directed Jerry to develop a Draft Permit for Tribal members for hunting and fishing, and bring it back to the Committee as soon as possible.

# 010-ONEIDA TRIBAL GENERAL FUND 1984 BUDGET

The Business Committee had in lewed the budget earlier and changes were made. Kathy was directed to make the corrections and bring back the budget in its final form, which she presented to the Committee today. Lloyd moved to approve the FY'84 budget. Loretta seconded. Motion carried.

## PAYROLL POLICY CHANGE - TONY BENSON

Memo was presented by Tony Benson stating that "payroll envelopes containing payroll checks of Tribal employees are the confidential property of the employees whose check is contained therein. The only insert allowable in these envelopes are those that pertain to the check itself. Such as: taxes, insurance, hours, etc. These inserts must have the written approval of the Tribal Treasurer. There will be no exceptions to this policy". Lloyd moved to refer the Payroll Policy to the Controller and Tribal Administrator. Loretta seconded. Vote on the motion was, one for, and three against. Motion fails. Loretta moved to have the Payroll Policy implemented immediately. Gordon seconded. Motion carried

Loretta moved to direct the Tribal Administrator to develop a recommendation to the Business Committee concerning a means of dissemination of information to Tribal employees. Gordon seconded. Motion carried.

## PERSONAL HOLIDAY REQUEST - LORETTA METOXEN

Loretta requests a personal holiday to be taken on September 23, 1983. Gordon moved to approve the request. Tony seconded. Loretta abstained. Motion carried.
