Lloyd also requested to attend a seminar on "The Free Book Program", on December 12, & 13, 1983 in Reno, Nevada. The purpose of this seminar is to establish a network of regional distribution centers in the United States to provide current reading and instructional materials, free of charge, to children, the ill, needy, and elderly Indian people which are unavailable from other sources. Through the expertise and sharing or information accumulated by the Ft. belknap Regional Distribution Center, questions from participants regarding the operation and maintenance of future centers will be answered before implementation.

Loretta made a motion to table this travel request until Lloyd consults with the Oneida Library and the Tribal School for their input. Kathy seconded. Notion carried.

040-EDUCATIONAL TV (RE: BINGU) - Rick Rockwell

Rick Rockwell met with some members of the Business Committee informally and explained that he would like to do a story on the Bingo operation of some of the tribes in Wisconsin. Oneida would be one of them. Kathy moved to approve the request to do a story on the Oneida Bingo and that Mark act as contact person. Lloyd seconded. Motion carried.

220-LAW OFFICE - Jerry Hill

Discussion on the Historical Statement concerning the Benson site. Jerry stated that at this time the Business Committee should consider not sending anything to the press, due to the many issues that are occurring at this time; the development or the new Commission, and the appeal of Green Bay over putting the 23½ acres of land in trust.

Kathy made a motion to modify the release of the unterial and not to send any information to the news media, only the two (2) County governments. Loretta seconded. Notion carried.
