Meeting was called to order at 9:00 A.M. by Chairman.

ATTORNEY DISCUSSION - Jerry Hill-Francis Skenandore

Jerry and Francis discussed the Washington D. C. meeting on November 10, 1983 at 10:00 A.M. in the BIA building, with the City of Green Bay, the Tribe, and the attorneys. They need to know how many will be attending. Lois moved that the Chairman be authorized to travel to Washington on the 8th through the 10th of November along with Gordon, Loretta and Jerry Hill. Kathy seconded. Motion Carried.

Amended summons and complaint: Francis brought up the amended summons and complaint by Pressentine on OTDC. We will then move to have that stricken at a later time. This amendment is to include the new members of the Business Committee.

Hill Burton law suit: Kathy asked Francis regarding the status of this suit. Kathy felt that this was settled. Francis will follow up on this.

Jerry Hill gave a short report on the Task Force Meeting he attended and the schedule of the next two meetings. One meeting was scheduled for November 14, 1983 in Tucson, Arizona. Another meeting had been scheduled for December 5, 1983 in Tampa and he feels that the Tucson meeting is not really necessary. The Task Force established two (2) sub-committees. One is responsible to outline the consideration regarding public relations and make a recommendation at the next meeting. The other sub-committee is to develop and propose regulations for the purpose of protecting tribes against outside consultant and management groups.

RESOLUTION FOR CHICAGO INDIAN CHILD WELFARE BOARD

Loretta moved to adopt Resolution No. 11-4-83-A, wherein the Oneida Business Committee appoints the Indian Child Welfare Program of Chicago to serve as an advocate for the Oneida Tribe, until such time that the Tribe is able to intervene and the Indian Child Welfare Program of Chicago report back to the Oneida Child Protective Board within forty-eight (48) hours of any action taken on behalf of the Oneida Tribe. Rick Hill seconded. Mark abstained. Motion Carried.

TRAVEL REQUEST

Rick Hill moved to approve the travel request for Lois Powles attend the Tristate Housing meeting in Superior, Wisconsin on November 10, 12, 1983. Loretta seconded. Lois Abstained. Motion Carried.

VACATION REQUEST

Lois Powless moved to approve the vacation request for Anthony Utschig, Tribal Administrator for November 21 and 23, 1933 and Personal Day for November 22, 1983. Lloyd seconded. Motion Carried.

ELAN CREDIT CARD RESOLUTION

After discussion on the resolution Lois moved to table until Monday. Mark Powless seconded. Motion Carried.

LEGAL FORUM

Discussion on the memo of October 27, 1983 to propose that the Oneida Tribe sponsor a Legal Forum in Wisconsin by lawyers who have won cases for Indian Tribes. Jerry feels this would be a chance for the committee to get some background information on cases. Lois moved that Lloyd and Rick work on this forum and bring back to the Committee. Kathy seconded. Motion Carried.

PERSONNEL

Mark Powless moved_to approve the recommendation of the Personnel Director to post the positions of Economic Development Specialist and Secretary at the Economic Development Office. Rick Hill seconded. Tony Benson opposed. Motion Carried.

Item number two was for information only. Notice of Internal promotion of Arlene Benson to Personnel Clerk/Assistant II position.

Item No. 3, Request for upgrade of personnel office secretary position was discussed. Question on change of grade level. Kathy moved to deny request to upgrade secretary position to Grade 9. Lois seconded. Loretta opposed because job description is similar to job description just passed and that is a beginning position at Grade 9. Kathy, Lois yes, Loretta, Mark, Rick, Tony, Lloyd opposed. Motion failed.

Loretta moved to honor the request for an upgrading. Lloyd Powless seconded. Mark moved to table the motion on the floor and have Dale Wheelock research this and bring back a recommendation in regard to all the secretarial positions, that they be uniform. Lloyd seconded. P.L. 81-874 - Harriet Alicea, Pat Cornelius

Harriet and Pat brought up concerns regarding PL-874, Impact Aid from the State to the Schools. The equalization formula for the school district was discussed along with what some of the action of other Tribe's such as the Arizona Tribes suing the State of Arizona. After lengthy discussion on all concerns, it was suggested that the possibility of a consultant be explored. Lois made a motion that Lloyd be required to followup on this and meet with whomever is necessary to get to the bottom of this whole mess to see what avenues the Tribe can take in pursuing this as far as the State is concerned. Lois also added that Lloyd pursue all avenues including Great Lakes Inter-Tribal Council. Loretta seconded. Motion Carried

INSPECTION COMMITTEE

In regard to Rick Hill's memo in which he felt some type of Inspection Committee for all the construction, etc. the Tribe is doing would be a good idea the Committee was of the consensus that a committee of this type is a good idea to protect the Tribe's interests. There was discussion on how to determine what type of committee this should be. Rick Hill made a motion that the Administrator and Planner develop a format for an inspection committee to be back on the table by next Wednesday. Loretta seconded. Mark abstained. Motion Carried.

ACHESON ESTATE SETTLEMENT

Kathy moved to approve items (1) \$5,000.00 donation to Rosa-Minoka Hill Foundation, (2) \$5,000.00 donation to Oneida Methodist Church in accordance with Mr. Acheson's wishes, of the suggestions as to the disposition of these funds. Lloyd seconded. Motion Carried. Lois and Rick abstained. Motion Carried.

Kathy moved to have Lloyd and the Education Department to come back with a plan of action of how the remainder of the monies could be utilized. Mark seconded. Kathy amended that the money remaining be put into an account immediately. Motion Carried
