080-Discussion on the Consortium with the Stock Bridge, Menominee and Winnebago to deal with Job Training Partnership Act (JTPA).

Tony had worked with Joe Reed, Planner of the Menominee Tribe, to develop strategy dealing with the state for funds from JPTA.

At the present time the state has designated Indian Tribes as Community Based Organizations (CBO) and the Governors Employment and Training Office has been assigned to work with CBO's. The Tribes are governments not CBO's. and through the Consortium we would approach the matter on a government to government relationship. Kathy moved to approve the proposal and attached Resolution #4-9-84-A with recommended correction. Lloyd seconded. Mark abstained. Motion carried.

A copy of this proposal will be sent to the Law Office for their review and comment. Bob Christjohn will be the designated staff at this time to work on drafting of By-laws and mission statement.

310-Discussion on Secretary/Receptionist for Business Committee.

The Tribal Administrator explained that the cost for this position would be \$6,140 for fiscal year 1984. Of this amount \$2,450 could be recovered from the JTPA Program through their OJT component. The balance of \$3690 would have to come from existing budgets. Tony recommended three alternatives that could be considered for providing the necessary \$3,690.

Dear Dr. Woesnner:

We most strongly support the Native American Graduate Education Program at the University of Wisconsin - Milwaukee. We see the need for an increased number of professional Indian educators to facilitate true self-determination and local reservation control in all areas of education.

We believe the NAGEP could facilitate and address the need for more American Indian educational administrators, teachers, counselors and educational researchers at the policy-making level. We urge the Department of Education to fund the proposal submitted by the School of Education at the University of Wisconsin - Milwaukee.
