Mark moved to amend the main motion to have a short narrative on the ballot to be developed by the Law Office based on the discussion. Gordon seconded.

#### 300-OTE ADVERTISING WITH WGEE - Bob Archiquette

Bob Archiquette brought in Christine Miller from WGEE Radio. He explained the advertising that has already been done and the effect it has had on OTE. This new package plan would start October 1, 1984 through November 2, 1984 and the cost would be \$2,990.00

Mark made a motion to approve the recommendation for the advertising program with WGEE, also Bob Archiquette is to bring back a recommendation on changes to the physical layout of OTE. Loretta seconded. Motion carried.

#### 200-OCCUPANTS OF VANSCHYNDEL FARM HOUSE

On Monday, July 6, 1984, the Business Committee tabled the request to approve the rental agreement of Eileen Blackdeer and RoseMarie Powless until verification of Tribal membership was made.

Reviewing the Tribal Rolls - none of the parties are on the Oneida Tribal Rolls. Kathy moved to take this item from the table, Lloyd seconded. Motion carried.
