PRESENTATION ON SELF HELP HOMES

Mr. Larry Seidel and Mr. Thomas R. Yost of Lake Superior Self-Help Homes, Inc were introduced. A presentation had been given on Tuesday evening, August 21 1984 which had a good turnout. This was a short version of that presentation There were numerous questions and discussion.

PERSONNEL:

Resident Assistant Report To Business Committee: There was an oversight on the hiring information not being presented to the Committee which was the reason for this report.

Discussion on the procedures of the Personnel Selection Committee.
