SPECIAL MEETING Approved as read. Reg. Mtg. 10/1/84

TUESDAY, SEPTEMBER 25, 1984

Meeting called to order by Vice-Chairman at 1:00 P.M.

150-DRAFT STATEMENT ON FORT HOWARD SLUDGE LAGOONS - John Spangberg

John Spangberg will be attending the Welfare and Protection Sub-Committee meeting regarding the air and ground water problems associated with the Fort Howard Sludge Lagoons. He presented the following draft position statement for the meeting:

- Tribal lands and programs are being impacted by the Fort Howard Sludge 1. Disposal Lagoons.
- Tribe is actively working with the WDNR and EPA to determine what these 2. impacts are as far as public health is concerned.
- 3. Want Fort Howard to monitor ground water impacts on Tribal Lands.

What The Problems Are:

- 1. Ground water dome with unknown levels of contamination has extended onto Tribal property and movement of ground water off site is to the south. Current dewatering is ineffective.
- 2. Ground water dome has affected vegetation along south side of dikes
- 3. Appear to be chemical changes happening in the soil and underwater (where dome has caused ponding).

4. Additionally, serious concerns about increases in odors coming off lagoons. Concerns are regarding, again, composition of materials.

After review and discussion, Kathy moved to approve the Position Statement deleting #4; that states no desire for legal action. Dave seconded. Motion carried.

040-BINGO PULL-TABS - Jerry Hill & Sharon Cornelius

Sandra Ninham, Alma Webster and Kate Stevens were also present for the Pull-Tab discussion. The Business Committee had met on September 24 on this matter and deferred any action until the Law Office had time to contact the Brown County District Attorney, Peter Naze, and then develop a recommendation on dealing with the pull-tabs. The Law Office presented three options:

- 1. Do nothing
- 2. Voluntary Compliance
- 3. Resist the Sheriff

Discussion followed on the options and the Business Committee felt that voluntary compliance would be the most advantageous to the Tribe.

Lloyd moved to approve voluntary compliance and within 30 days the Law Office work on changing the Bingo Ordinance and prepare for possible litigation. In addition the Sheriff will be notified that after September 30, 1984, the Tribe will not be selling the Pull-tabs as we are presently doing. Kathy seconded. Mark and Gordon opposed. Motion carried.

REQUEST FOR A GENERAL TRIBAL COUNCIL MEETING TO DISCUSS POLICY & PROCEDURES OF THE SELECTION/GRIEVANCE COMMITTEE - Judy Cornelius & Betty Dennison

Mark moved to deny the request and that Judy Cornelius and Betty Dennison be informed of the sub-committee that has been developed to review the Policy & Procedures. Also that Judy and Betty be invited to attend and participate with this Committee. Lloyd seconded. Motion carried.

060-TRAVEL REQUEST

Kathy, Gordon, Lois, Rick, Amelia Cornelius, Amos Christjohn (all of the Litigation Committee) and Jerry Hill requested travel to the Supreme Court Hearings in Washington, D.C. on October 1, 1984 and then go on to Syracuse New York, which reconvenes October 3-5, 1984.

Mark moved to approve the request, David seconded. Gordon and Kathy abstained. Motion carried.
