Human Resource Classification by Grades

#### Re-employment information:

The Personnel Office wishes to inform the Oneida Business Committee that Frances Monica Powless has been reinstated in her former position as a Bingo Worker on April 5, 1985.

Upon discharge from Active Military duty, Monica has requested re-employment and length of service pay commensurate to her peers.

The Personnel Office has reviewed Monica Powless' request and in compliance the the Re-employment Rights Law, Federal Law (Chapter 43 of part III of Title 38, U.S. Code) which gives re-employment rights to people who leave their jobs to serve in the Armed Forces, has reinstated Monica Powless as Bingo Worker at a pay rate comparable to her peers.

#### DONATION POLICY - Kathy Hughes

It is the policy of the Oneida Tribe to support organizations and/or individuals whose goals and objectives are in conformance with Tribal goals and objectives.

The Finance and Appropriation Committee will review all requests for donations. The requests must be submitted in writing on or before April 1, of the Fiscal Year. The request should clearly define the purpose for which the donation is being asked with an explanation, where possible, of how it conforms to Tribal goals and objectives.

A set amount will be identified on an annual basis. Finance and Appropriations will recommend funding to the Business Committee based on the availability of funds.
