#### TABLED CONSULTANT AGREEMENT BETWEEN JOANN SWAMP AND THE LAW OFFICE

Kathy moved to take this item from the table. Lloyd seconded. Motion carried.

The funds for this agreement were requested as a tribal Contribution. Rick Hill, Don Wilson and Sharon Cornelius have since worked out a budget modification and reimbursement of past services from the Indian Child Welfare Program. There are enough funds for Jo Swamp for a period of ten weeks.

Kathy moved to approve the Consultant Agreement between Jo Swamp and the Law Office effective June 17, 1985. Lloyd seconded. Motion carried.

## RESUBMISSION OF JERRY DELGADO'S CONTRACT - Sharon Cornelius

A contract was approved for Jerry Delgado on June 11, 1985. Sharon has a new contract for the Business Committee to review because of a change in the contract.

Lloyd moved to table the resubmission of Jerry's contract until Friday, June 21, 1985 and Sharon will have the revision for the new contract. Kathy seconded. Motion carried.

#### TRIBAL SPECIFIC HEALTH PLAN FOR FY'86 - Barbara Hawkins

This plan gives a historical perspective, the current structure and health status and resources. Also the prioritization of Health Program Initiatives The Business Committee reviewed the plan with Barbara Hawkins and made some recommendations. Any additional recommendations should be submitted by Friday, June 21, 1985. Barbara will be sending the plan to Indian Health Service next week.

Lois moved to approve the plan with the added recommendations. Lloyd seconded. Motion carried.

- Procedural Exception to Hire Two Additional Bingo Security by Promotion

Lois moved to approve the recommendation of a procedural exception for Susan R. Pospychala and Mark A. Stanchik to be promoted to a part-time position and these people would attend N.W.T.I. for Police Science in the fall at which time they would be put on full time in security. Gordon seconded.

After more discussion, Lois withdrew her motion for lack of clarification on the security work force problem. The filling of these two positions will not solve the problem of overworking of the security staff.

Kathy moved to table until June 21, 1985 for a report on the staffing requirement and the present hours of security at Bingo. Lois seconded Gordon opposed. Motion carried.

- Posting of Inventory Supply Clerk

The Personnel Office requested authorization to post the property management and receiving clerk positions. The Personnel Office modified the job description entitled Inventory Supply Clerk to that of Property Management and Receiving Clerk as per Business Committee Minutes of March 1, 1985.

Lloyd moved to approve the posting of the revised job description. Gordon seconded. Lois abstained. Motion carried.

- Upgrading File Clerk Position in Accounting

The Personnel Office requests the upgrading of the file clerk position from grade 4 to grade 6 because of additional duties to the job.
