## SPA REPORT - David King

Of one hundred thirty-four (134) questionnaires turned in, nine (9) were negative votes. People have other ideas other than favoring a spa facility. Most of the supportive votes requested information for a pool, regulation size or olympic size.

Dave approached "Cho" of Cho's Taik Wondo for a moderate price for our workers and our people. He gave Dave two offers. Fifty (50.00) dollars per person for a group of over two hundred fifty (250) people per year or, three hundred (300.00) dollars for ten (10) years for the same number of people.

Dave is also looking at an Employment Assistance Program which would handle some of the employees personal problems. The exercise concept might relieve some of the health problems that we currently have within the Tribe. If there is enough interest by the Tribe, it's possible that we consider this alternative to accept Cho's offer.

#### SPA REPORT (CONTINUED)

The hotel will have weights, sauma, swimming pool, according to Bruce King. Bruce also states that there is a possibility that some special arrangements can be made to use the facility. He will be getting in contact with the Management Team and then inform Dave of his findings.

If there are no other suggestions and/or questions regarding the spa, Dave will discontinue plans for the construction of this facility.

Average costs that people were willing to pay according to the questionnaire are:

Single: \$177.77 Married: \$151.38 Family \$178.55

These figures clearly indicate that we probably could not afford and support a spa.
