RESOLUTION FOR TRIBAL SCHOOL #8-6-85-B

This resolution is needed for entering into contracting with B.I.A.

"It is in the interest of the Oneida people and their progeny that the Oneida Tribe of Indians of Wisconsin provide a Tribal School for the education of Indian youth of this area."

"The Oneida Business Committee hereby endorses and supports the entering into contracting with the Bureau of Indian Affairs for the purpose of providing funds for the Oneida Tribal School base program and ancillary programs including:

INTERNAL INVESTMENT POLICY & PROCEDURE FOR INTERNAL INVESTMENT PROPOSALS

Law Office Present: Jerry Hill, Jo Swamp, Francis Skenandore, Sharon Cornelius.

The Law Office revised the Policy as per request: POLICY

It is the policy of the Cneida Tribe that the Investment Committee shall consider INTERNAL ONEIDA TRIBAL INVESTMENT PROPOSALS, as referred by the Oneida Business Committee, on the basis of their merit. Such proposals will be considered and judged upon the reliability of their proposed projected returns. It is the further policy that such proposed investments be compatible with the long term goals of the Oneida Investment Committee and the specific requirements of each particular fund.

APPLICATION PROCEDURE

- I. Such proposals must be submitted by any recognized department, committee, or other tribal sub-organization.
- II. The purpose of such proposals and benefit to the Tribe shall be clearly and concisely setforth in the proposal.

INTERNAL INVESTMENT PROPOSAL POLICIES (CONTINUED)

- III Each initial Internal Investment proposal shall set forth in brief concise statements:
 - A. a narrative
 - B. a budget
 - C. a detailed projected basis for the return
- IV Copies of the proposal shall be provided to the Tribal Treasurer, who will inform the Business Committee thereof.
- V. Internal Investment proposals must not be considered, if
 - A. they are submitted by an individual tribal member for personal benefit, or
 - B. by any group or person that are not formally associated with the Oneida Tribe
 - C. they do not benefit the Oneida Tribe or a specific fund from which such investment money is requested.

Dave moved to approve, Gordon seconded. Lois and Lloyd opposed. Rick abstained. 4 members voted yes. Motion carried.

RESPONSE TO SUSAN ISAAC

Jerry Hill responded to the letter from Susan Isaac explaining the process that the Business Committee is required to go through when a tribal member is in violation of internal Oneida Tribal rules or agreements.

HEARING ON ESTABLISHMENT OF AN OFFICER OF INDIAN AFFAIRS WITH THE STATE OF WISCONSIN

There is a hearing scheduled at Rd Cliff on August 16, 1985 on this matter Jerry will be attending to state Oneida's view.

GREENHOUSE DEVELOPED AS A POSSIBLE ENTERPRISE - Lloyd Powless

Lloyd presented an article on how the Cherokee developed Cherokee Gardens into a profit making enterprise. After discussion, Lloyd moved to have the Economic Development Office review the possibility of this type of enterprise for the Tribe and give the Business Committee a report. Kathy seconded. Motion carried.

RESOLUTION #8-6-85-A

- WHEREAS, The Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States; and,
- WHEREAS, The Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin; and,
- WHEREAS, The Oneida Business Committee has been delegated the authority of Article IV, Section I of the Oneida Constitution by the Oneida General Tribal Council to protect and preserve the sovereignty of the Oneida Tribe, its rights and its resources; and,
- WHEREAS, The Oneida Business Committee has duly adopted a Bingo Ordinance regulating the conduct of bingo on the Oneida Indian Reservation which is authorized under Article IV, Section 1, (f) of the Oneida Constitution; and,

WHEREAS, The Bingo Ordinance provides by Article VI, Number 17;

- 17. Alcohol and Drugs: No alcoholic beverages and/or illegal drugs shall be allowed on Tribal premises where bingo is conducted. Anyone caught possessing and/or using alcoholic beverages or illegal drugs shall be removed from the premises and barred from playing bingo on Tribal premises.
- WHEREAS, On July 20, 1985, Louis A. DiLocova, President of Fortune Enterprises, Inc., while on Tribal land on the Oneida Indian Reservation, during a bingo session at the Irene Moore Activity Center, was detained by an Oneida Tribal Security Officer on duty, Greg Powless, and voluntarily gave to Officer Powless a vial of a white powder, he referred to as his medication, which was subsequently determined to be cocaine, and which conduct of Louis A. DiLacova was reported by Officer Powless, a copy of which is hereby incorporated by reference; and
- WHEREAS, The Oneida Tribe of Indians of Wisconsin reserves the right to exclude those persons from tribal premises who violate Oneida Tribal Ordinances.
- NOW, THEREFORE BE IT RESOLVED, That Louis A. Diloccva, Fortune Enterprises, Inc., all persons employed by Fortune Enterprises, Inc., and all other associates of said corporation, are hereby barred from all tribal premises and from doing business where bingo is being played.

Dave moved to approve Resolution #8-6-85-A. Kathy seconded. Motion carried
