- Creation of Expediter Position and a Procedural Exception to put Peter Jordan in this position from his Present position as Plant Manager.

The rational for this request is based on the needs of the Building & Grounds Department for an Expediter in setting up work schedules, evaluate work cost and inspect work assignments as a completion and quality of work performed. At present these responsibilities are performed by the Plant Manager, Peter Jordan, which takes time away from the administrative functions of the Plant Manger.
