APPEAL OF LIANE HILL

Loretta Metoxen explained the reasons why Liane appealed the decision of the Housing Authority to terminate.

After listening to Liane Hill's statements and reviewing her documents and reviewing the documents of the Oneida Housing Authority, Mark moved to deny the request from the Housing Authority to terminate based on the following:

Denial of the Termination is based upon the failure of the Notice of the Housing Authority to specify the provision of Section 6, which applied and thus, the Notice was vague and could not be addressed. The lease provision in question provides five (5) conditions of agreement which the tenant must abide. The Notice of Termination to the tenant, dated July 10, 1986 cited; .. "The breach of the Rental Agreement, Section 6." and nothing more. Minutes of the meeting of the Oneida Housing Authority held on August 18, 1986 indicates that the discussion referred to "May 5, 1986 unauthorized lodger..." but did not reflect that the tenant specifically responded to that assertion. Thus, the Notice was invalid for failure to specify which provision of Section 6 of the Lease the tenant was accused of violating. Notices must specifically advise the tenant, in detail, precisely what they are accused of being in violation of. If the Notice is inadequate, the alleged violator has been denied due process of law.

Dave seconded. Tony abstained. Gordon opposed. Motion carried.
