IHS & STATE SOIL TESTERS

IHS & State Soil testers in regard to problems with soil testing on the reservation. Problems with IHS accepting state testing results. IHS stated there is a large number of unmet needs in the Michigan/Wisconsin area. Discussion on Kevin Cornelius site. IHS will not accept state tests. IHS stated the site was marginal, the cost is excess, and the site is too close to former dump site. Also that Mr. Kurowski should not have sent letter to Mr. Cornelius stating that he would receive services from IHS for a well and septic system. State testers stated that the site was not marginal and was acceptable for a mound system. They do not get involved with wells. Discussion only.

3. GROUP HOME UPDATE REPORT - David Webster/Kathy King

The Group Home will be an eight bed community based AODA treatment program for a target population of 13-18 year old youth. The program will target boys the first year. Staff will cover for 24 days. Funding is from state AODA program, IHS, Third Party billing, and tribal contribution. Future need is to look at a home for young girls and for temporary care.

Volunteer relinquishment of Cynthia M. Schmitz from Oneida Tribal Rolls. David King moved to approve the request, Ernie Stevens seconded. Loretta Metoxen abstained. Motion carried.

B. Use of Tribal Van for 1 Day Symposium on Indian Program at Hampton, Sept. 16, 1989-Mary LeMieux

Larry Barton moved to allow the use of the Business Committee van for this trip, Amelia Cornelius seconded. Motion carried. Mary LeNieux from the Museum will be responsible for the van. It was suggested that Charlene Cornelius be informed of the trip, and with her supervisor's approval, she might be able to attend to copy some of the information and evaluate the records at Hampton.

C. Recommendations for Oneida Child Protective Board

Lloyd Powless moved to approve the recommendations of Harriet Reiter, Cally King, Tony Benson, and Virginia Johnson to serve on the Child Protective Board. David King motion carried. 4 members for, (Kathy Hughes, Amelia Cornelius, Lloyd Powless, David King), 3 opposed (Ernie Stevens, Loretta Metoxen, Rick Hill), Larry Barton abstained. Motion carried.

D. Resignation of Two Nursing Home Commission Members

Resignation of Shirley Powless and Barbara Schuman from Nursing Home Commission. Rick Hill moved to accept the resignations, Loretta Metoxen seconded. Motion carried.

Amelia Cornelius moved to repost the two positions for 30 days, David King seconded. Motion carried.

E. Law Enforcement, Legal Assignment - Ernie Stevens

Formation of Police and fire Commission. Ernie Stevens moved that the Tribal Attorney and the legal department be given the permanent assignment of coordinating all assignments and reviews related to the subjects of law enforcement, but not day to day supervision. Further, that the Committee to establish a Police and Fire Commission shall be Larry Barton, Ernie Stevens Sr., Gerald L. Hill, and the Chief of Public Safety; such committee to complete their work for consideration by the Oneida Business Committee by December 1, 1989. Amelia Cornelius seconded. Motion carried.

Amelia Cornelius moved to have the request for title search on the land requested by Lisa Metoxen, completed by Attorney Jo Swamp. David King seconded. Motion carried.

- 3. Sewer Ordinance Attorney Cornelius

Loretta Metoxen moved to approve option 5 of the recommendation "that MSD sign the contract with the Tribe, and thereby reserve to Metro the authority to deal with residents of the Town of Hobart who are non-Indian who live on fee land residing within the boundaries of the Town of Hobart, the Tribe would thus bill MSD for all non-tribal usage and Metro would bill the individual residents and be responsible for their payment. The Tribe would pursue contracts with individuals." Ernie Stevens seconded. Rick Hill opposed. Motion carried.

4. Introduction of Canadian Oneidas

Gordon McLester introduced Canadian Oneidas: Ray George and Charles Cornelius.

- 5. Chas Wheelock asked if his request for funds for General Tribal Education were being included in the budget process. He was informed that it was scheduled in with the final mark-up sessions in early September.
- 6. Debbie Powless asked question on who and why persons were selected for the Indian Child Welfare Board. Lloyd Powless stated that his recommendation included two that were recommended by the Board and two recommended by the Chairman.
