GENERAL TRIBAL COUNCIL RESOLUTION # 7-3-89-A

WHEREAS, the Oneida General Tribal Council is the duly recognized governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee may be delegated duties and responsibilities by the Oneida General Tribal Council and is at all times subject to the review powers of the Oneida General Tribal Council, and

WHEREAS, the General Tribal Council has been delegated the authority of Article IV, Section I of the Oneida Tribal Constitution, and

WHEREAS, the Oneida General Tribal Council is concerned with developing an economy on the reservation that will provide jobs, income and other benefits for the Tribe and its members, and

WHEREAS, the enterprises of the tribe are managed by the General Manager who reports to the Business Committee, and

WHEREAS, the Oneida General Tribal Council desires to consider the establishment of an alternate structure to manage and conduct oversight of tribal enterprises, enterprise corporations, and development activities, and

WHEREAS, the Oneida General Tribal Council desires to provide for such a review and change in an orderly manner, consistent with established and sound business management principles and operating procedures.


NOW THEREFORE BE IT RESOLVED: that the General Tribal Council hereby directs the Oneida Business Committee to implement a plan of action and report progress at the January meeting of the Oneida General Tribal Council, and

BE IT FURTHER RESOLVED: that an "Enterprise Review Committee" is established by the General Tribal Council and the Oneida Business Committee is directed to implement this resolution.

BE IT FINALLY RESOLVED: that a majority of the Review Committee shall be chosen from the Oneida General Tribal Council and members should be experienced in Business Management, Finance, Accounting, and Administration.
