#### MINUTES:

All meeting minutes are submitted to the Tribal Secretary's office as they are approved.

#### **ACTION TAKEN:**

- 1. Staffing Levels remain our top priority of this fiscal year. We are the hiring process for more officers. We have one retirement this quarter. We thank all our dedicated men, women and K-9's that serve our Community.
- 2. The Oneida Police Department is currently in the Law Enforcement Accreditation Process. What does that mean for the Nation and the Community? This process ensures that we are providing the highest quality service to our community through review of our standards and processes. Ensuring we are consistent, fair, and professional in the way we conduct the business of protecting our community. Each Policy and Procedure are reviewed, re-written and approved. There are over 85 individual policies and procedures that govern our law enforcement officers in the field.
- 3. Our computer Aided Dispatch is in the process of being upgraded and has only affected our ability to recapture response time data. All other functions are operating as needed. MIS is working with the Department to resolve the issue.
- 4. A Youth Prevention & Intervention site has been established over at Ridgeview in Suite 7. Our Gang Prevention Task Force Coordinator has been working with Social Services in providing a safe place for youth to come and re-capture educational credits and start learning life skills. Mandy has done an excellent job writing for grants that we hope will be awarded within the next year.
- 5. Take 25 Event was held on May 31, 2005. Purpose is to get parents and community members to take 25 minutes to talk to your children about safety.

#### FINANCIAL:

Our approved budget for FY 14 is \$100,000. We are currently operating within our budgeted projections for the current fiscal year.




