## BC Resolution 03-12-14-E Regarding Pardon of Kelly Braaten

- WHEREAS,** the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States of America, and
- WHEREAS,** the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS,** the Oneida Business Committee has been delegated the authority of Article IV, Section 1, of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS,** the Oneida Pardon and Forgiveness Screening Committee reviewed the pardon application of Kelly Braaten at a duly called hearing held on February 20, 2014, and
- WHEREAS,** the requirements of the Pardon and Forgiveness Law have been fulfilled.

**NOW THEREFORE BE IT RESOLVED,** that the Oneida Business Committee by this resolution hereby:

Approves the pardon of **Name** for the crime(s) of \_\_\_\_\_, and notifies the Oneida Tribe of Indians of Wisconsin and its agencies that **she/he** is recognized as a member of the Oneida Tribe of Indians of Wisconsin to have all the benefits and opportunities available to all other persons as if the criminal offenses(s) pardoned by this resolution did not exist. The pardon has been approved based on the following:

1. List of reasons for approving the pardon per 5.9-3.

Denies the pardon of Kelly Braaten, for the crime(s) of DUI 5<sup>th</sup> and DUI 6<sup>th</sup>, and notifies her that she may request another pardon after one (1) year from the date of certification of this document. The pardon has been denied based on the following:

1. List of reasons for denying the pardon per 5.9-3.

- Needs to continue AODA treatments
- Needs to be off probation longer
- Live a productive lifestyle while maintaining sobriety
