
Reallocation of Self Governance Housing Development Funds to the Senior Citizens Program

- WHEREAS,** the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government, a Treaty Tribe recognized by the laws of the United States, and a Self-Governance Tribe with the Department of the Interior's Bureau of Indian Affairs and with the Department of Health and Human Service's Indian Health Service; and
- WHEREAS,** the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin; and
- WHEREAS,** the Oneida Business Committee has been delegated authority under Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council; and
- WHEREAS,** it is the mission of the Oneida Tribe of Indians of Wisconsin to protect and improve the resources, the standards of living, and the environment in which the Oneida people live while maintaining, enforcing, and exercising the sovereign rights of the Oneida Nation; and
- WHEREAS,** the Oneida Tribe of Indians of Wisconsin has determined that safe, sanitary and accessible housing is necessary in order to enable Tribal elders to remain in their homes and maintain their standard of living; and
- WHEREAS,** Article I, Section 2(b) of the Compact of Self-Governance with the U.S. Department of the Interior provides that the Oneida Tribe of Indians of Wisconsin can reallocate funds for such programs, activities, functions, or services according to its Tribal priorities; and
- WHEREAS,** Section 2 of the 2005 Self-Governance Funding agreement states that the Oneida Tribe of Indians of Wisconsin has broad authority to consolidate and reallocate funding between programs without further approval from the Secretary of the Department of the Interior.

NOW, THEREFORE, BE IT RESOLVED: the Oneida Tribe of Indians of Wisconsin directs that the Housing Development line item funds negotiated in each annual P.L. 93-638 Self-Governance Funding Agreement beginning with the CY 2005 Funding Agreement be reprogrammed to the Oneida Tribe's Higher Education Scholarship Program to be used to provide scholarships to eligible Tribal members, and that an equivalent amount of Tribal contribution funds be transferred from the Scholarship program to the Oneida Senior Center to be used to provide Elderly Services.
