RESOLUTION # 5-11-94 N

WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and a treaty Tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida general Tribal Council, to manage all the economic affairs and enterprises of the Oneida Tribe, and

WHEREAS, the Oneida Tribe has acquired in fee status the following parcel described as: Ron Peterson Property

Commencing at the intersection of the Southeasterly Right of Way Line of the Green Bay and Western Railroad Company and the Northerly line of Claim 153; thence S 62°-52'-00" E along the said northerly Line 672.50 feet; thence S 30°-56'-32" W 579.71 feet to the Point of Beginning; thence S 30°-40'-32" W 308.78 feet to the Southerly Line of Indian Claim 153 and the Center Line of C. T. H. "J" and West Service Road; thence N 59°-11'-00" W along Said Southerly Claim Line and Said Center Line 260.91 feet; thence N 30°-45'-03" E 125.02 feet; thence S 59°-11'-00" W 112.89 feet; thence N 30°-45'-03" E 373.92 feet; thence S 56°-12'-03" feet to the Point of Beginning except those lands now being used for Highway Purposes and subject to easements and reservations of record. Parcel contains 104,877 square feet (2.4 acres), more or less

WHEREAS, the above described parcel is requested in Trust Status to expand Oneida Tribal land base and provided a future site for economic development, housing, recreation, conservancy, and agriculture, and

WHEREAS, the Oneida Business Committee certified that the local property taxes will be paid up to Trust placement, and

NOW, THEREFORE, BE IT RESOLVED, THAT THE Oneida Business Committee hereby requests the United States Bureau of Indian affairs to initiate and carry out the prices required to place the above parcel in Trust for the Oneida Tribe of Indians
