


# Oneida Tribe of Indians of Wisconsin

## Resolution # 05-12-10-K

### Regarding Pardon of Faron Beilke

- Whereas,** the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and a treaty tribe recognized by the laws of the United States, and
- Whereas,** the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- Whereas,** the Oneida Business Committee is delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- Whereas,** the Oneida Pardon Screening Committee reviewed the pardon petition at a duly called public Pardon Hearing on behalf of Faron Beilke, and
- Whereas,** the requirements of the Oneida Pardon Ordinance and Oneida Pardon Procedures Policy have been fulfilled, and

**Now therefore be it resolved** that the Oneida Business Committee by this resolution hereby:

- Approves the pardon of Faron Beilke, Petitioner, and notifies the Oneida Nation and its employing agencies that the Petitioner is recognized as a member of the Oneida Nation to have all the benefits and employment opportunities available to all other persons as if the criminal past pardoned by this resolution did not exist.
- Denies the pardon of Faron Beilke, petitioner and notifies the petitioner that he may request another pardon after one (1) year from the date of certification of this document.

### CERTIFICATION


