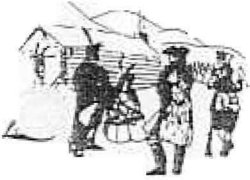

## RESOLUTION # 7-10-96-HH

WHEREAS, the Oneida Nation of Wisconsin is a federally recognized Indian government and a treaty tribe recognized by the laws of the United States, and

WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Nation of Wisconsin, and

WHEREAS, the Oneida Business Committee has been delegated the authority of Article IV Section 1 of the Oneida Tribe Constitution by the Oneida General Council, and

WHEREAS, the goal of the Oneida Nation of Wisconsin is to protect, maintain and improve the standard of living and the environment in which the Oneida people live; while maintaining and re-establishing the sovereign rights of the Oneida Nation of Wisconsin, and

WHEREAS, under the Constitution and By-Laws of the Oneida Nation of Wisconsin, the Oneida Business Committee is charged with the duty of protecting and enhancing the health, security, and general welfare and advancement of the Oneida Nation of Wisconsin, and

WHEREAS, the Bureau of Indian Affairs is conducting a National Road Inventory Update to collect uniform data for all Indian Reservation Roads, and


WHEREAS, Tribal governments have the option of participating as a contractor under P.L. 93-638, using Indian Preference when subcontracting, in the collection of Indian Reservation Road data, and

WHEREAS, the Oneida Nation of Wisconsin has significant expertise to competently perform the scope of work for Phase III of the National Road Inventory Update Project.

NOW THEREFORE BE IT RESOLVED, that the Oneida Nation will participate in Phase III of the National Road Inventory Update Project as a 93-638 contractor, according to this project's scope of work, to collect data for all Oneida Nation Indian Reservation Roads.
