RESOLUTION 08-26-10-H

Annual Funding Agreement Negotiated with the Department of the Interior's Bureau of Indian Affairs for Calendar Year 2011 and Calendar Year 2012


- WHEREAS,** the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government, a Treaty Tribe recognized by the laws of the United States, and a Self-Governance Tribe with the Department of the Interior's Bureau of Indian Affairs and with the Department of Health and Human Services' Indian Health Service; and
- WHEREAS,** the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin; and
- WHEREAS,** the Oneida Business Committee has been delegated authority under Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council; and
- WHEREAS,** it is the mission of the Oneida Tribe of Indians of Wisconsin to protect and improve the resources, the standards of living, and the environment in which the Oneida people live while maintaining, enforcing, and exercising the sovereign rights of the Oneida sovereignty; and
- WHEREAS,** the Oneida Business Committee has determined that entering into a Self-Governance Compact and annual Funding Agreement (FA) with the U.S. Government's Department of the Interior pursuant to P.L. 93-638, as amended, supports and enhances the Oneida Tribe of Indians of Wisconsin's sovereignty.

NOW, THEREFORE, BE IT RESOLVED: that the Oneida Tribe of Indians of Wisconsin approves the Reprogramming Request and annual Funding Agreement negotiated with the Department of the Interior's Bureau of Indian Affairs for Calendar Year 2011 and authorizes the Treasurer to sign the Reprogramming Request as negotiated and authorizes the Chairman to sign the Funding Agreement as negotiated.

BE IT FURTHER RESOLVED: that the Oneida Tribe of Indians of Wisconsin, being a base budget Self-Governance Compact Tribe with the Department of the Interior's Bureau of Indian Affairs, authorizes the Chairman and Treasurer to sign the Calendar Year 2012 Funding Agreement and Reprogramming Request when and as negotiated.
