RESOLUTION # Q-2/-94I

WHEREAS,

the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and a treaty tribe recognized by the laws of the United States, and

WHEREAS

the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and

WHEREAS

the Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and

WHEREAS.

the Oneida Tribe has acquired in fee status the following parcel described as: Tim and Kathy Dolata Property, 3976 W. Mason, Green Bay, Wisconsin.

WHEREAS

the parcel is described as follows Parcel A

PART OF INDIAN CLAIM 163, TOWN OF HOBART, BROWN COUNTY, WISCONSIN MORE FULLY DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHWEST CORNER OF INDIAN CLAIM 163; THENCE S89 DEGREES 52' 32" E, 1194.85 FEET ALONG THE NORTH LINE OF SAID INDIAN CLAIM 163 TO THE NORTHERLY RIGHT-OF-WAY OF S.T.H. WHEREAS, the above described parcel is requested in trust status to expand Oneida Tribal land base and provide a future site for economic development, housing, recreation, conservancy, and agriculture, and

WHEREAS, the Oneida Business Committee certifies that the local property taxes will be paid up to trust placement, and

NOW, THEREFORE BE IT RESOLVED, that the Oneida Business Committee hereby requests that the United States Bureau of Indian Affairs to initiate and carry out the process required to place the above parcels in trust for the Oneida Tribe of Indians of Wisconsin.
