RESOLUTION # 10-01-97-G

- WHEREAS, the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian government and Treaty Tribe recognized by the laws of the United States, and
- WHEREAS, the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS, The Oneida Business Committee has been delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- WHEREAS, Roger A. Yealey, a tribal member and Monica Schindler, a non-tribal member are holders of lease no. RL-2393(93), described as follows:

A parcel of land located within NE 1/4 SE 1/4 Section 11, T 23 N., R 18 E, 4th P.M., described as follows: Commencing at the E 1/4 corner of Section 11, thence West 396 feet to the Point of Beginning; thence continuing West 264 feet; thence South 330 feet; thence East 264 feet; thence North 330 feet, more or less, to the Point of Beginning, containing 2.0 acres, more or less, subject to all valid rights-of-way of record.

WHEREAS, Roger A. Yealey and Monica Schindler wish to modify residential lease no. RL-2393(93) be **\*\*MODIFIED\*\*** as follows:


DELETE: Roger A. Yealey, a tribal member, and Monica Schindler, a non-tribal member




