


Oneida Tribe of Indians of Wisconsin

Resolution 10-26-11-F Regarding Pardon of William Jourdan


- Whereas,** the Oneida Tribe of Indians of Wisconsin is a federally recognized Indian Government and a treaty tribe recognized by the laws of the United States, and
- Whereas,** the Oneida General Tribal Council is the governing body of the Oneida Tribe of Indians of Wisconsin, and
- Whereas,** the Oneida Business Committee is delegated the authority of Article IV, Section 1 of the Oneida Tribal Constitution by the Oneida General Tribal Council, and
- Whereas,** the Oneida Pardon Screening Committee reviewed the pardon petition at a duly called public Pardon Hearing held on September 15, 2011 on behalf of William Jourdan, and
- Whereas,** the requirements of the Oneida Pardon Ordinance and Oneida Pardon Procedures Policy have been fulfilled, and

Now therefore be it resolved that the Oneida Business Committee by this resolution hereby:


- Approves the pardon of William Jourdan, petitioner, and notifies the Oneida Tribe of Indians of Wisconsin and its employing agencies that the Petitioner is recognized as a member of the Oneida Tribe of Indians of Wisconsin to have all the benefits and employment opportunities available to all other persons as if the criminal past pardoned by this resolution did not exist.
- Denies the pardon of William Jourdan, petitioner and notifies the petitioner that he may request another pardon after one (1) year from the date of certification of this document.

CERTIFICATION


