Because of the help of this Oneida Chief in cementing a friendship between the six nations and the colony of Pennsylvania, a new nation, the United States was made possible.


## BC Resolution 11-09-11-D Extension of Emergency Adoption of the Vendor Licensing and Permitting Regulations, OGC R#1

- WHEREAS,** the Oneida General Tribal Council is the duly recognized governing body of the Oneida Tribe of Indians of Wisconsin, and
- WHEREAS,** the General Tribal Council has been delegated the authority of Article IV, Section I of the Oneida Tribal Constitution, and
- WHEREAS,** the Oneida Business Committee may be delegated duties and responsibilities by the Oneida General Tribal Council and is at all times subject to the review powers of the Oneida General Tribal Council, and
- WHEREAS,** the Tribe-State Gaming Compact requires the Oneida Tribe of Indians of Wisconsin to conduct background investigations regarding gaming-related contractors, and
- WHEREAS,** the Oneida Nation Gaming Ordinance under section 21.6-14(i) delegates responsibility to the Oneida Gaming Commission to license vendors with contracts with a gaming operator, and
- WHEREAS,** the Oneida Gaming Commission is delegated responsibility under section 21.6-14(c) of the Oneida Nations Gaming Ordinance to draft regulations subject to approval by the Oneida Business Committee in order to carry out the commission's delegated responsibilities, and
- WHEREAS,** the State of Wisconsin, under section X(A) of the Tribe-State Compact, conducts audits of the gaming operations and has identified as a finding the need for background investigations regarding gaming-related vendors with contracts in excess of \$50,000 independent of the background investigation conducted by the State of Wisconsin, and
- WHEREAS,** the Oneida Gaming Commission has identified regulations under which vendors of the gaming operations will be licensed and how those background investigations will be conducted which require implementation immediately in response to the state audit finding, and
- WHEREAS,** the Administrative Procedures Act, under section 1.5-1 requires a Public Hearing to be held regarding these regulations unless an emergency exists which would jeopardize the health, safety, or general welfare of the reservation population under section 1.6-1(a), and
- WHEREAS,** the Oneida Business Committee approved the emergency adoption of these regulations through BC-05-25-11-B, and
- WHEREAS,** the regulations are being prepared for public hearing, however, the emergency amendments that are in place will expire before the regulations can be permanently adopted, and
- WHEREAS,** actions impacting the ability to conduct gaming operations or to protect the integrity of the gaming operations jeopardize the general welfare of the reservation population.

**NOW THEREFORE BE IT RESOLVED,** that the Oneida Business Committee finds that an emergency exists requiring the emergency adoption of the Vendor Licensing and Permitting Regulations, OGC R#1, for an additional six (6) months, effective upon the expiration of the original emergency adoption.

### CERTIFICATION
