Present: Chrm. Norbert Hill, Vice Chrm. Lee McLester, Treas. Althea Schuyler, Sec. Woodrow W. Webster.

Meeting called to order by Chairman Norbert Hill. The Housing Authority committee present for joint meeting. Mr. Hill asks Anderson Cornelius to bring Housing Authority Committee to order.

Artley Skenandore asks the tribal council to meet with the Housing Authority for approval of the tribal council to resolution requesting additional roads for housing project site.

Motion by Lee McLester to accept the resolution requesting additional roads for the housing project site. Motion carried. This resolution seconded by Woodrow Webster.

The Housing Authority informs us that the PHA at the Chicago office wishes to revise the housing program reservation for elderly people. The tribal council and housing authority concurred with sending letters to Marie McGuire, director of the IHA in Washington, DC and to Senator Proxmire in opposition to this revision.

Lee McLester makes a motion to send letters to Marie McGuire and Senator Proxmire opposing a revision of the housing program. Seconded by Woodrow Webster. Motion carried.

A motion by Althea Schuyler to adjourn the joint meeting with the Housing Authority. Seconded by Lee McLester. Carried.

A motion by Lee McLester to donate \$25.00 to the Wisconsin Indian Summer Project. Seconded by Althea Schuyler. Carried.

A motion by Lee McLester to pay bill of \$29.00 to Althea Schuyler for roll work and stamps. Seconded By Woodrow Webster. Carried.

A motion to adjourn by Lee McLester. Seconded by Woodrow Webster. Carried.
