MINUTES

Meeting called to order by Chrmn. Norbert Hill.
 Reading of the minutes of the June 7, 1965 meeting. Artley Skenandore makes a motion to accept the minutes as read. Sec. by Ruth Baird. Treasurer's report by Althea Schuyler. Questions about treasurer's report by the floor. Why there was no itemized report of all monies spent by the Exec. Council. Pearl McLester made motion to table this report. Sec. by Irene Moore. Coffee break.
 Chrmn. Hill calls the meeting to order at 9:15 p.m.

Correspondence:

Letter from Mr. E.J. Riley to Mr. Albert Muench informing him of the transfer of land from the Diocese of FonduLac to the U.S. in trust for the Oneida Tribe of Wis.

Progress report made by Artley Skenandore of the Oneida Public Housing construction may began by September. Questions from the floor.

Mr. Grasser representing Mr. Riley introduced by Chrmn. Hill

No word to report on the Constitution and by-laws.

Community Action Program report by those instructed to visit the public high schools for remedial education program for Oneida Indian students under the E.O.A. August will be the month that the Youth Education program will be held as reported by Ruth Baird.

Artley Skenandore reports that Oneida has four college students conducting a summer recreational program. They are sponsored by the Wis. Indian Service Project. Chrmn. Hill has them intorduce themselves. They are David Little Swallow and his sister Vicki from New Town, North Town, North Dakota, Susan Colgate from Maryland and Dottie Dutton from Whitewater, Wis. Chrmn. Hill urges the tribe to support these young people.

Mary Powless reports on the United Council of Churches Conference in Eau Claire, Wis. on the 19th of June.

Resolutions read, one for low rent and mutual help program for terms of 25 years and optional 25 years. Artley Skenandore moved for adoption of resolutions. Sec. by Ruth Baird. Carried.

Chrmn. Hill brought up the subject of collecting on delinquent loans. It was his desire that the floor discuss it so ideas can be discussed as how to do so. Artley Skenandore suggested that the Exec. Council be delegated to decide what can be done with the advice of the B.I.A.

A motion was made by Mrs. Abbie Skenandore that the Chrnm or Exec. Committee be authorized to select a committee to work with them in regard to delinquent loans and land assignments. Sec. by Ruth Baird. Carried.

New Business: Election of new member to Oneida Housing Authority. Oscar Archiquette and Elmer Wheelock were nominated. Elmer Wheelock declined. Artley Skenandore made motion that Oscar Archiquette be accepted as the new member for four years. Sec. by Ruth Baird. Carried.

A motion was made by Anna John that the chrnm. be able to choose his own committees to work with him on any tribal business. Sec. by Artley Skenandore.

Old Business: Artley Skenandore made a motion to accept the treasurer's report as read. Sec. by Pearl McLester. Motion carried. Correspondence read requesting to work on election board for the coming July 24th elections. Louis Williams, Nancy E. Summers, Mary Powless and Anderson Cornelius are to be on the board.

New Business: Mrs. Irene Moore made a motion that \$2.00 be charged for registering new members on the tribal roll and the hour rate be discontinued. Nominations open for tribal officers:
