MINUTES

The meeting was called to order by Norbert Hill, Chairman, at 7:00 p.m.

A letter was read from the law firm of Bond, Schoenock and King, concerned the authority of Norbert Hill to act for the Tribe in the Contingent fee contract with them.

At a regular meeting of the Executive Committee of the Onondaga Tribe of Indians held October 13, 1966, continued to November 9, 1966, with all of the Council members present (Norbert Hill, Chairman; Oscar Archiquette, Vice-Chairman; Ira Cornelius, Secretary; Joycelyn Bishop, Treasurer). All members of the Executive Committee present with Norbert Hill presiding. The Chairman stated that he had received a photostatic copy of an undated letter from the BIA to Bond, Schoenock and King received by them on October 19, 1966, wherein objection was made in the form of the execution of the contingency fee contract with said firm and that it was necessary and proper that the Executive Committee adopt resolution ratifying, confirming and approving the act of Norbert Hill in the execution of said contract.

Upon motion duly made and second the following resolution was unanimously adopted.

Whereas Norbert Hill as Chairman of the Onondaga Tribe of Indians of Wisconsin and a member of the Executive Committee of said Tribe has pursuant to a resolution of the Executive Committee of said Tribe adopted at a regular meeting held August 8, 1966, heretofore executed a contingent fee contract with the law firm of Bond, Schoenock and King of Syracuse, New York.

Be it resolved that the act of Norbert Hill in the execution of said contract for and on behalf of said Executive Committee and Tribe be in the same hereby ratified, confirmed and approved and that the contract shall stand as if the same had been executed in the name of the Executive Committee of the Tribe.

Upon motion duly made and second the following resolutions enclosed were unanimously adopted:

(Lease land for Corniel Skenandere and Dolores Skenandere)
(Lease land for Clayton Cornelius and Arletta Cornelius)

Resolution adopted for Eldred Nickles and Carolina Nickles for land lease was made and second. Not yet signed by lessees.

Motion to continue meeting at a later date. Second and approved.
